

2025 TRAINER & AGENT 1% REBATE

POLICY

Inglis will pay a one per cent (1%) rebate to trainers and agents in recognition for their efforts in attracting new owners to Inglis Select Yearling Sales. Only trainers and agents who have been invited to participate in the scheme are eligible to apply for a rebate.

QUALIFYING CRITERIA

All claims must satisfy the below criteria:

- 1. The trainer or agent must personally purchase the horse and complete the transaction documentation, accepting responsibility for full settlement of the account. A call buyer does not qualify for a claim by simply placing their name on the ticket.
- 2. To assist Inglis with the collection of proceeds, the trainer or agent must ensure the full purchase price of each horse is paid strictly within 30 days of the sale.
- 3. The trainer or agent must personally be involved in the inspection and selection of horses being considered for a rebate. The rebate is to reward them for their time and effort in the selection process and for the time they invest in recruiting new owners to Inglis Sales.
- 4. The trainer or agent must provide Inglis with an official tax invoice to claim the rebate within **60 days** of the date of purchase. The rebate is not to be deducted from the purchase price.

CONDITIONS

- 1. Inglis will only pay the Trainer & Agent 1% Rebate once Inglis has been provided with, and is satisfied with proof of payment for all purchases along with an offical tax invoice.
- 2. The Trainer & Agent 1% Rebate is extended to buyers at Inglis' Select Yearling Sales only, unless otherwise agreed in writing.
- 3. Dual rebates will not be paid on a horse. A rebate will not apply where the purchase is already subject to an International or Australasian Investment Subsidy. For example, if Inglis pays for an owner or buyer to attend the sale from overseas a rebate will not be paid on horses purchased on their behalf by a trainer or agent.
- 4. No horse that is bought back for the vendor will be eligible for a rebate.
- 5. Inglis reserves the right to reject any rebate claim and withdraw the rebate agreement at any time.
- 6. Inglis reserves the right to deduct the value of any travel expenses or incentives paid from the value of the rebate.
- 7. All 2025 Trainer & Agent 1% Rebate claims for 2025 Inglis Yearling Sales Series must be received within 60 days of the date of purchase or prior to 30 June 2025, whichever of which comes first.
