

# Race Series Terms and Conditions

Terms and conditions of qualification for the Inglis Race Series 2026

Applicable to eligible horses born in 2024

## 1. RIGHT TO BE ENTERED FOR INGLIS RACE SERIES

1.1 For the purpose of this clause the following sales conducted by William Inglis & Son Limited (Inglis) are approved sales.

- Australian Weanling Sale 2025
- Great Southern Weanling Sale 2025
- Classic Yearling Sale 2026
- Premier Yearling Sale 2026
- Australian Easter Yearling Sale 2026
- HTBA Yearling Sale 2026
- Inglis Digital Online Auctions (Yearlings - August 1, 2025–July 31, 2026)
- Inglis Digital Online Auctions (Weanlings – August 1, 2024–July 31, 2025)
- Ready2Race Sale 2026

1.2 Subject to clauses 1.5, 1.6 and 1.7, all eligible horses must have been offered for sale through the approved sales listed under 1.1. In the case of live yearling or Ready2Race auction sales, a horse must have been through the sale ring to qualify. In the case of a weanling sale or Inglis Digital auction, a horse must have been sold at the sale.

1.3 Following the offer of a horse for sale at an approved Inglis Sale but subject to clauses 1.2 and 2.3, the owner of that horse has the right to have that horse entered for the Inglis Race Series.

1.4 For the avoidance of doubt, only horses sold or passed in subject to clause 1.2, at an approved Inglis Sale are qualified to be entered for the Inglis Race Series.

1.5 If a horse is passed in at an approved Inglis Sale and is subsequently sold, such subsequent sale must be a sale by Inglis conducted under its Conditions of Sale in order to be or remain eligible to be qualified to be entered for any of the Inglis Race Series.

1.6 If a horse is offered for sale at two or more approved Inglis Sales, eligibility for the Inglis Race Series is determined on the basis that such horse was offered for sale at

the latter of such sales. Inglis reserves the right to determine otherwise at its discretion.

1.7 Any horse which has been sold or passed in at a sale not conducted by Inglis which is then subsequently sold or passed in at an approved Inglis Sale may be entered into the Inglis Race Series at the absolute discretion of Inglis.

1.8 Any horse which has been sold or passed in at a sale not conducted by Inglis is not eligible for the Inglis Race Series, unless it is subsequently sold or passed in at an approved Inglis Sale subject to clause 1.1 and 1.2.

## **2. ENTERING HORSES FOR INGLIS RACE SERIES**

2.1 The Owner of a horse which is qualified for entry into the Inglis Race Series who wishes to enter the horse into the Inglis Race Series must lodge the Nomination Form, together with the prescribed Nomination Fee (including GST) by 5pm July 31, 2026.

2.2 The Nomination Form, together with the prescribed Nomination Fee, must be lodged in the prescribed manner as directed on the Official Nomination Form on the Inglis Website [www.inglis.com.au](http://www.inglis.com.au) or by completing the Nomination on the acknowledgement of purchase docket at the time of purchase.

2.3 Inglis reserves the right to reject any Nomination Form or extend the time to lodge such nomination for the Inglis Race Series in its absolute discretion and without being obliged to give any reason therefore.

## **3. INGLIS RACE SERIES & INGLIS BONUS SERIES**

3.1 Races as described below are each part of the Inglis Race Series

- \*Inglis Restricted Races
- \*Inglis Triple Crown Races
- \*Inglis Pink Bonus Series
- \*Inglis Xtra Bonus Series

3.2 The date, distance, venue, prizemoney (to the extent such prizemoney can be determined by Inglis) payable in respect of any race by Inglis, in the Inglis Race Series or any Inglis Race Series Bonus and the terms upon which such prizemoney will be payable, will be advised on the Inglis website and may be subject to change.

3.3 No prizemoney will be paid by Inglis in respect of any Inglis Race Series race or any Inglis Race Series Bonus despite a horse otherwise being so entitled if any swab, objection or inquiry procedure results in the disqualification of that horse. In the event any such prizemoney has already been paid by Inglis, such amount as has been

paid is, upon the disqualification, immediately repayable by the recipient to Inglis as a debt due.

#### **4. INGLIS RESTRICTED RACES**

4.1 Inglis Restricted Races are races in which only horses that have been entered into the Inglis Race Series are eligible to compete.

4.2. Other than in respect of the rules regarding the eligibility for nomination and acceptance of horses to run in the Inglis Restricted Races including the distribution of prizemoney, Inglis Restricted Races are to be conducted in accordance with the Australian Rules of Racing and the Principal Racing Authority conducting the meeting at which the Inglis Restricted Race is being run.

#### **5. INGLIS TRIPLE CROWN BONUS RACES**

5.1 The Inglis Triple Crown consists of the following races.

##### **Leg 1: Either**

- RL 2YO Inglis Banner, 1000m
- RL 2YO Inglis Nursery, 1000m

##### **Leg 2: RL Inglis Millennium, 1100m**

##### **Leg 3: ATC G1 Inglis Sires' Produce Stakes, 1400m**

5.2 If won, the Inglis Triple Crown Bonus including applicable GST will be distributed to:

- a. 80% to the Owner/s of the horse after Leg 3 is won.
- b. 10% to the Trainer or Training Partnership of the horse after Leg 3 is won.
- c. 5% to the Breeder/s of the horse as described in the Australian Stud Book when the horse was offered for sale.
- d. 5% to the Owner/s of the horse at the time it was offered for sale, at the sale the horse is eligible for the race series.

5.3 Other than in respect of the distribution of a bonus to be paid by Inglis to a horse that has been entered in the Inglis Race Series, the Inglis Triple Crown races are to be conducted in accordance with the Australian Rules of Racing and the Principal Racing authority conducting the meeting at which the races are run.

5.4 Should a horse entered in the Inglis Race Series dead-heat for first place in any leg of the Inglis Triple Crown, any bonus payable at the conclusion of the Inglis Triple

Crown will be awarded except if two or more horses entered in the Inglis Race Series dead heat for first place in all three legs of the Triple Crown, in which case the bonus will be divided equally between all such horses.

## 6. INGLIS PINK BONUS SERIES

6.1 The first registered horse home in each of the races listed below will be eligible for an additional bonus, on top of the existing prizemoney payable, as outlined below.

- 2026 Inglis Banner, \$400,000, Flemington - **\$200,000 Inglis Pink Bonus**
- 2026 Inglis Nursery, \$400,000, Royal Randwick - **\$200,000 Inglis Pink Bonus**
- 2027 Inglis Millennium, \$2,000,000, Royal Randwick - **\$400,000 Inglis Pink Bonus**
- 2028 Inglis Sprint, \$750,000, Flemington - **\$200,000 Inglis Pink Bonus**

6.2 The Pink Bonus will be payable subject to the following conditions

- To the winner of any Pink Bonus race, 100% of the Bonus will be payable
- If the first eligible horse home finishes 2<sup>nd</sup> or 3<sup>rd</sup>, 50% of the Bonus will be payable
- If the first eligible horse home finishes 4<sup>th</sup> or worse, 10% of the bonus will be payable

6.3 To be eligible for the \$1,000,000 Inglis Pink Bonus Series, any horse must be eligible for, fully nominated and paid up for the Inglis Race Series and be a minimum 75% owned or leased by female owners. For a horse to be eligible for the Pink Bonus Series, the Managing Owner, as registered with Racing Australia, must be female. There will be no additional entry fee for eligible horses to be nominated to the Inglis Pink Bonus Series.

6.4 Registrations for the Inglis Pink Bonus Series for horses born in 2024 must be submitted by 5pm on September 1, 2026

6.5 Graduates of the 2026 Inglis Ready2Race Sale will be eligible for registration. Registrations for graduates of the 2026 Inglis Ready2Race Sale must be submitted by 5pm on October 20, 2026.

6.6 Only 1 registration form is necessary per horse. To be eligible, the relevant horse must be born in 2024, be nominated and fully paid up for the Inglis Race Series.

6.7 The horse must be a minimum 75% owned and/or leased by female owners at all times from September 1, 2026, through to and including participation in any of the eligible Pink Bonus races as outlined above.

6.8 The ownership (or lease) must remain unchanged from the time of registration for the Pink Bonus Series through to participation in any of the eligible Pink Bonus races as outlined above other than with the prior approval of Inglis. Should there be a change in ownership a horse may still be eligible for the Pink Bonus subject to meeting the ownership criteria in clause 6.7. Inglis reserves the right to determine otherwise at its discretion.

6.9 If the horse is not fully syndicated and/or registered with Racing Australia at the time of registering to the Pink Bonus Series the person nominating the horse acknowledges that the horse will be eligible for the Pink Bonus under the conditions of the Bonus and will provide necessary ownership details once registered with Racing Australia.

6.10 Bonus payments will be made by Inglis to the registered Owner(s) and Trainer(s) as recorded by Racing Australia. Any Pink Bonus payment is to be paid 90% to the registered owner and 10% to the registered trainer or training partnership. Inglis reserves the right to withhold any bonus payment at its discretion.

6.11 Any Inglis Pink Bonus prizemoney won will not count towards the official prizemoney earnings of the horse as recorded by Racing Australia or any other official racing authority.

## **7. INGLIS XTRA BONUS SERIES**

7.1 Inglis will pay a \$100,000 Bonus to the winning connections of any nominated Maiden race.

7.2 To be eligible for the \$5,000,000 Inglis Xtra Bonus Series, any horse must be eligible for, fully nominated and paid up for the Inglis Race Series, be aged three years old or above and born in 2021, 2022, 2023 or 2024.

7.3 The details of each the 50 nominated Maiden races will be published by Inglis in reasonable time before each race, with the series scheduled to be run between August 1, 2027 – July 31, 2028.

7.4 If a nominated Maiden race is divided into two or more races, for any reason, the Bonus will be split pro rata.

7.5 Bonus payments will be made by Inglis to the registered Owner(s) and Trainer(s) as recorded by Racing Australia. Any Inglis Xtra Bonus payment is to be paid 90% to the registered owner(s) and 10% to the registered trainer or training partnership. Inglis reserves the right to withhold any bonus payment at its discretion.

7.6 Any Inglis Xtra Bonus prizemoney won will not count towards the official prizemoney earnings of the horse as recorded by Racing Australia or any other official racing authority.

## **8. GOODS AND SERVICES TAX (GST)**

8.1 Prize money is paid on a GST exclusive basis. Where owner/s, trainer/s or breeder/s are registered for GST, GST will be added.
